PORTRAITS



Clémentine Prieur

Clémentine Prieur is a mathematician internationally recognized for her contributions to both probability and statistics. Her pioneer results on characterizing the probabilistic notion of dependency have allowed the statistical community to deal with new problems. We can cite among others the statistical problems of parametric and non-parametric estimation for dependent data and diffusions. For example, she has greatly contributed to the problem of inference in stochastic damping Hamiltonian systems.

Clémentine arrived at LJK in 2008 in the MAD department, department which was not the most natural for her, coming from the stochastic community. Nevertheless Clémentine is the kind of personality who is not afraid by challenges. She has successfully faced this one: introducing randomness in the deterministic community. She has deployed an incredible energy and amount of work to integrate the community of uncertainty quantification and climate modeling. She has been in charge of the national GDR MascotNum, developing numerous industrial collaborations and multidisciplinary projects in a very dynamic way. She has co-supervised 7 PhD students since her arrival in Grenoble, all of them at the interface of the deterministic and the stochastic approaches, thus enriching the interactions between the two communities.

From these experiences and to answer questions from her collaborators, she has invested new themes such as model reduction, sensitivity analysis or extremes theory in environment and climate. She is now a pillar of the INRIA team AIRSEA. Her point of view has led to new approaches and new questions in the projects of AIRSEA, especially in the field of uncertainty quantification and sensitivity analysis. She is now a leading researcher in this domain.

To conclude, Clémentine is a very energetic person, involved in an incredible amount of projects covering an impressive large palette of applied mathematics. She has been recently awarded by the Prix Blaise Pascal, proving once again her leadership at the national and international level.



Jean-Charles Quinton

Jean-Charles Quinton joined the LJK as an assistant professor in 2015. As a member of the Statistics for Life Sciences and Humanities team (SVH), he interacts heavily with colleagues from psychology and neuroscience. Before arriving in Grenoble, he did a PhD in artificial intelligence, worked in various labs on computational neuroscience and robotics (France, Japan, UK, and Italy), and was then recruited as an assistant professor at the interface between computer vision, robotics, and psychology in Clermont-Ferrand in 2011.

Interdisciplinarity may best characterize his activities, with a commitment to cognitive sciences. His approach is to craft intelligent systems to better study the principles driving cognition in living systems. While he participates(ed) in the co-supervision of 9 PhD students on seemingly various projects and disciplines, all subjects revolve around predictive (unsupervised) learning; how agents may extract and exploit regularities in their environment, and how predictions may themselves continuously drive interactions (e.g. active learning and active perception).

Such predictions may take many different forms in Jean-Charles's work depending on the level of abstraction and applicative domain: I) pure neural or sensorimotor adaptation (e.g. tracking through eye movements), 2) dynamic decision-making in complex situations (e.g. risk-taking in driving situations), 3) planning of future actions while taking into accounts local constraints (e.g. co-articulation in manipulation), 4) influence of regularities observed in our social environment over the years (e.g. implicit stereotypes on math not being made for women, simply due to observed frequencies), 5) reasoning about the expectations of others (e.g. desirability bias in human interactions).

In practice, experimental data are analyzed statistically, and complex dynamical systems simulated. For instance, the dynamic neural field framework approximates the brain activity with integro-differential equations. Decisions may then be characterized by attractors, and behaviors as trajectories passing through heteroclinic channels.

Whether it be for computer science or statistics, teaching requires the assimilation and manipulation of concepts by students. Jean-Charles therefore works on the interactivity of pedagogical platforms, trying to facilitate the learning of regularities in equations, visual representations, numbers, and empirical observations. This loops back with predictive learning, connecting teaching and research...

PORTRAITS



M(I)



Julyan Arbel started a research position at Inria in 2016. Prior to that, he worked at Insee where he completed a PhD in statistics (CREST and Paris Dauphine) and then did a postdoc at Collegio Carlo Alberto (Turin) and Bocconi (Milan). He also worked abroad for one- to three-month periods during his studies at Ecole Polytechnique and Ensae and during his early career, including at University of Liverpool, Universitat de València and University of Texas at Austin.

His research within statistics focusses on the Bayesian paradigm, thus called after Thomas Bayes and his eponym formula, which models parameters as random variables and turns data into useful quantities. Julyan works on nonparametric models, that are highly flexible models which adapt to data complexity by allowing for an infinite number of parameters. The flexibility of these models comes at a computational and technical price. In this context, Julyan's research contributes to better understanding and justifying Bayesian inference in high-dimensional models and data, and proposes feasible and scalable algorithms in a background of data analysis in neuroscience, ecology and astrophysics.

During his Ph.D., Julyan identified a class of prior distributions with optimal and adaptive behaviour for increasing data size. He also proposed a platform for modelling partially replicated data which alleviates the need for empirical data. This has been used in ecology to derive toxicology recommendations of a fuel spill region in Antarctica. Addressing computational issues, Julyan focusses since then on approximations of models, obtaining algorithms which scale with large sample size, while maintaining low error rates, and being able to measure them. Tools employed include discovery probabilities, point processes (Fig I), while techniques include Laplace approximations, moment matching methods (Fig 2), concentration inequalities...

Julyan also loves popularizing science: he writes about his research on the collaborative blog Statisfaction, is a member of the board of *Variances.eu*, the webzine of Ensae, is an R enthusiast involved in the Grenoble R User Group and author of R packages (eg. momentify, Fig 2), and used to interact with MATh.en.JEANS teams in Italy and the International Mathematics Competition team of Polytechnique. He launched the monthly reading group Bayes in Grenoble (*https://sites.google.com/view/bigseminar/*), and co-organises the Stat4Astro summer school in 2017, the Bayesian learning theory workshop in 2018, and Statlearn 2019. With more than 60 talks since the start of his PhD, Julyan is a passionate traveler to conferences and seminars.

Conference - debate series « Understanding & Acting » ⁷ Team STEEP - Scientific mediation

> Saving Civilization is not a spectator sport. (Lester Brown)

Following a dynamics of exponential growth in a finite world, humanity today faces a number of unprecedented and tightly interlinked challenges. With a growing number of environmental limits being largely and irreversibly exceeded (GHG concentrations in the atmosphere, biodiversity loss, soil erosion, freshwater shortages...), social, economic, geopolitical, humanitarian (etc.) consequences are becoming more urgent than ever to address, while the threat of an uncontrolled global collapse is now more than a prospect. It is urgent to initiate deep, structural, socioeconomic changes on virtually all aspects of our increasingly global societies (economics, industrial and agricultural production, consumption, education, all requiring major new local and global policies).

In view of these facts, the STEEP research team has initiated in 2016 a series of conferences-debates entitled "Understanding & Acting" (« Comprendre et agir ») that examines these issues in order to help researchers and citizens to increase their awareness of the various issues at stake in order to initiate relevant individual and collective actions. From now on, the scientific community at large must realize that its duty also lies in helping citizens to better understand these issues. If the fraction of people in society whose privilege is to be paid to think about society's problems do not seize this opportunity in the critical times we face, who will? Researchers must become more involved in the search of socioeconomic alternatives and help citizens to implement them. The interactions between researchers and citizens must also to be reinvented.

The presentations of this series of conferences typically last between 30 to 45 minutes; they are followed by a 45 minute public debate with the audience. The presentations are captured on video and then made directly accessible on the YouTube Channel "Comprendre et Agir". At the end of 2017 the YouTube channel counts more than 40,000 views with a rate of integral viewings remaining at above 25%.

PERSYVACT2

[,] Team SVH

Persyvact2 is a collaborative research team that aims at developing cutting edge data science methodologies to analyze large biomedical data. Persyvact2 consists of about 20 researchers from GIPSAIab, LJK and TIMC-IMAG. Coming from different fields related to data science (statistics, machine learning, image and signal processing), members of Persyvact2 analyze biomedical data generated from neuroscience, genomics, and clinical trial research. The key structures of biomedical data that Persyvact2 exploit consist of graph structures, repeated experiments and their intrinsic lower dimensional representation.

The aim of Persyvact2 is to perform collaborative research and to bring together researchers of different scientific fields interested by data science. Persyvact2 seeks to enhance the international visibility of data science in Grenoble. Persyvact2 has provided funding for 2 PhD about biostatistical analysis of large-scale biomedical data.

pcadapt is an R package to look for footprints of natural selection in human genomes. The package implements cutting-edge data science method to extract information from high dimensional genomic data. It has been applied to a large human genomic dataset to find genes involved in adaptation. Another R package to process large genomic data is under construction (https://github.com/privefl/bigsnpr) and should be delivered in 2017.

In neuroscience, we constructed a new graph metrics entitled the "hub disruption index". This metric allows to show that stroke induces a network-wide pattern of reorganization in the contralesional hemisphere.

Persyvact has organized the statlearn 2015 workshop about statistical machine learning. Around 150 participants attended to the workshop. Perysvact2 has organized the journées MAS (about stochastic processes and statistics) in Grenoble in 2016.

Future

Collaboration with epidemiologists from the Institute for Advanced Biosciences IAB initiated by the Epigenetic & High-Dimension Mediation Data Challenge (June 7-9 2017, Aussois), which is organized by Persyvact2. The objective is to understand if epigenetic mediates the effect of environmental exposures (air pollution) on child health.

In neuroscience, we anticipate that graph modeling and metrics such as the "hub disruption index" can become a useful tool for clinical applications.

Applications of cutting data-science to biomedical data is the focus of a work package of the Cross Disciplinary Research project DATA@UGA funded by the IDEX Université Grenoble Alpes (2017-2020). A 3-year junior chair whose research concerns data-science applied to biomedical data will be recruited.

New statistical models to understand and predict oculometric data

The PERSYVAL-Lab Oculo Nimbus project-team focuses on characterizing human-environment interactions through eye movements. Indeed, these reflect dynamic exploration of visual regions of interest. This project aims at developing new statistical tools for eye-movement analysis, potentially augmented with multimodal data (electroencephalography - EEG - or mouse tracking). Such models are dedicated to: (i) the segmentation of spatiotemporal data of visual exploration into cognitive phases, (ii) the analysis of spatiotemporal dependencies in fixation prediction, (iii) the analysis of ocular fixations with a higher spatial resolution for understanding the functional roles of microsaccades (miniature eye movements during multistable perception) in visual perception. The main specificity of the project is to capture information from eye movements at different scales: spatiotemporal scale from low-level information extraction to high level tasks and usages, in a multimodality context.

(i) EEGs and eye movements were recorded during some press review tasks, in which reading and decision making are intertwined. Hidden Markov models (HMMs) were used to segment the sequence into reading strategies, each having well statistically identified eye-movement properties. We are extending such HMMs to jointly analyze eye movements and EEGs. Similarly, Markovian models were used to analyze eye and hand movements (computer mouse) during the resolution of IQ test items, to distinguish resolution stages and strategies.

(ii) As far as image exploration is concerned, two approaches were developed: firstly, sparse semi-parametric spatial point processes with covariates were used to predict the sequence of fixations on images in tasks of visual exploration. Secondly, the dependence between chromatic and luminance information in images and the effect of the associated information redundancy on eye movements was analyzed.

(iii) At a finer spatio-temporal scale, ocular micro-movements (microsaccades occurring during eye fixations) have been identified as a noise factor facilitating decision making processes during perception. Theoretical models based on stochastic resonance allow for an improvement in the prediction process of decision making. Ongoing work focuses on explanatory models of these perceptional phenomena in the framework of multistable perception.

The Jean Kuntzmann Prize

Professor Joachim Weickert, from Saarland University, is the second recipient of the Jean-Kuntzmann Prize, and has been awarded on April 14th 2016 at the Grenoble Museum of Art.

The Jean Kuntzmann prize was created by LJK and the labex PERSYVALlab on the model of the « distinguished lecture series », which are popular in American universities. The prize is awarded to academics who made exceptional contributions, which may be transverse to the fields of mathematics, computer science, or operational research, and who, like Jean Kuntzmann, have an interest for the application of their research to solve some of our society's problems.

Joachim Weickert is professor of mathematics and computer science at Saarland University where he has been the leader of the Mathematical Image Analysis Group since 200I. He received a diploma and a Ph.D. degree in mathematics from the University of Kaiserslautern (1991, 1996), and a habilitation degree in computer science from the University of Mannheim (200I). He worked as research assistant at the University of Kaiserslautern, as post-doctoral researcher at the universities of Utrecht and Copenhagen, and as assistant professor at the University of Mannheim.

Joachim Weickert performs research in image processing, computer vision and scientific computing, focusing on techniques based on partial differential equations, variational principles, wavelets, morphological and nonlocal methods. He has developed mathematical models and efficient numerical algorithms for image restoration, enhancement, segmentation, compression, optic flow computation, stereo reconstruction, shape from shading, as well as signal processing methods for tensor fields. These ideas have entered a number of applications in industry, biomedical image analysis and other fields.

Joachim Weickert has received 32 research, teaching and reviewing awards, including a Gottfried Wilhelm Leibniz Prize. In 2017 he has been awarded an ERC advanced Grand. He is elected member of the Academia Europaea - The Academy of Europe.

During his stay in Grenoble, Joachim Weickert gave a series of talks on Variational Models for Motion Estimation in Videos, Osmosis in Visual Computing, and Cyclic Schemes for PDE-Based Image Analysis. He also gave during his award ceremony a public lecture entitled "Image Compression with Differential Equations".

SCIENTIFIC RESULTS OF THE TEAMS

Ageing and Maintenance in reliability: Modeling and Statistical Inference (AMMSI) [,] Team FIGAL

Managing the reliability of industrial equipment is a major economic and societal issue. This requires to better control the ageing of these systems, to adapt the maintenance strategy, and to accurately estimate their residual life, while respecting safety, regulation and operational performance. Depending on the occurred events and monitoring devices, the aging of a material can be undetectable before its failure, or result in an observable degradation. Moreover, the aging can be slowed by the effect of maintenance actions, either corrective or preventive. Therefore, the impact of maintenance on aging has to be assessed, and maintenance has to be planned optimally. This goal can be achieved by the proposal of probabilistic models of degradation, failure and maintenance, and the development of appropriate statistical analysis methods.

To that aim, the AMMSI project was funded by ANR from 2012 to 2016. Coordinated by LJK for Grenoble INP, the other members were Université de Pau et des Pays de l'Adour, Université de Franche Comté, Université de Technologie de Troyes, EDF and SNCF Réseau. Gathering complementary academic and industrial partners, AMMSI resulted in a successful coupling between basic and industrial research.

From the academic point of view, the work done during the project allowed to propose, on one hand, new stochastic models for the degradation, failure and maintenance of complex systems, and on another hand, new statistical methods for analyzing experience feedback data, such as estimation methods and goodness-of-fit tests. From the application point of view, the industrial partners now can use an expanded range of models and analytical methods adapted to a wide variety of possible operational situations. They can also use decision making tools for the industrial implementation of these methods. Thus, the results of the project contribute to improve the management of industrial assets, to assess more precisely the reliability of equipment, and to optimize their maintenance. The work done has been published in a hundred of papers in the best refereed journals and international conferences of this field of research. It also led to the development of two packages of the statistical software environment R, EWGOF and VAM.

SCIENTIFIC RESULTS OF THE TEAMS

GeoSpec strike force ⁷ Team CVGI

The mathematical theory of complexity is that of classifying objects or problems based on how difficult they are to apprehend or to solve. It is a well known research subject in applied mathematics for example in Numerical Analysis or Combinatorics where estimating the number of steps needed to compute a quantity is crucial in the perspective of a computer implementation. In more fundamental mathematics, for example in Geometry or Dynamical Systems, the exact geometry of an object is rarely known with sufficient accuracy: for instance it may be altered with time, as is the case of structure of the Universe. For these reasons, the features of an object are often appraised in terms of associated algebraic or analytic quantities (for instance, the decay rate of the solution of a Partial Differential Equation, etc.), which pave the way to a measure of their complexity.

The purpose of the present project is to develop a synergy between fundamental and applied mathematicians in order to study important problems related to the complexity of two-dimensional objects (such as surfaces) and initiate investigations in higher dimension where the situation is, for most problems, widely unknown. In this project we aim at studying the complexity of the geometry of a mathematical object (e.g. a manifold) through three different aspects: its metric (that is, the way distances are measured on the object), its dynamics (i.e. the trajectories followed by particles moving on it) and its spectrum (i.e. its resonance frequencies). More specifically, we intend to study extremal manifolds for invariants describing this complexity in each of the above items.

We illustrate below one of our first results obtained by the synergy provided by this enthusiastic group of researchers. This new approach aims to identify "opposite" points of a given location on a surface. More precisely, we define the set of "opposite points" as the points for which it exists at least two different shortest paths connecting the point and the location. On a sphere for instance, every point has one and only one opposite point which is precisely its antipodal point. On a general surface, the set of opposite points is called the cut locus of the location and may have a huge topological complexity. The following pictures show examples of approximation of cut loci for different topological surfaces.

Numerical optimal transport and inverse problems in optics

The field of non-imaging optics consists in designing optical components whose goal is to transfer the radiation emitted by a light source to a prescribed target in an optimal way. This question is at the heart of many applications where one wants to optimize the use of light energy by decreasing light loss or light pollution, such as car headlamp design, public lighting, solar ovens and hydroponic agriculture. In the last years, we have considered the design of different kind of lenses or mirrors that satisfy some light energy constraints. To be a bit more specific, given a light source and a desired illumination (target) after reflection or refraction, the goal is to design the geometry of a mirror or a lens which optimally transports the energy emitted by the source onto the target. Note that these mirror or lens design problems can be regarded as inverse problems, where the forward one would be to simulate, for instance by raytracing, the target illumination from the description of the light source and the geometry of the mirror or lens.

In many settings these problems amount to solving a generalized Monge-Ampère equation on the plane or on the sphere which is equivalent to an optimal transport problem. In collaboration with Q. Mérigot and J. Kitagawa, we proposed a Newton algorithm to efficiently solve optimal transport problems and proved its convergence for general cost functions. We also developed a code able to solve optimal transport problems accurately for a target discretization up to one million points and applied it to the design of eight different lenses or mirrors. We also collaborated with the company Optics, together with the Gipsa-Lab, for the automatic realization of car light beams.

Continuity Editing for 3D Animation

[,] Team IMAGINE

We propose a continuity editing model for 3D animations that provides a general solution to the automated creation of cinematographic sequences. Our model encodes the continuity editing process as a search for the optimal path through an editing graph. In this editing graph, a node represents a time-step (a temporal fragment of a shot), and an arc represents a transition between two cameras, going from a camera to either the same camera (no cut) or another camera (cut).

Our optimization uses dynamic programming to minimize, under a semi-Markovian hypothesis, the errors made along three criteria: the quality of the shots (with respect to the unfolding actions), the respect of continuity editing rules and the respect of a well-founded model of film editing rhythm (cutting pace). Semi-Markov models have been used before in the context of information extraction, speech generation and computer vision. To the best of our knowledge, this is the first time they are suggested as a computational model for film editing.

To validate our approach, we recreated the animation of a well-known scene from Robert Zemeckis' movie "Back to the future" with four main characters, all engaging in a variety of actions, including two-way and three-way dialogues, physical contacts, and everyday activities such as sweeping the floor and serving food. All animations were manually annotated to provide (subject; verb; object) descriptions at the right time-codes and twenty-five cameras were manually placed for the whole duration of the sequence. We performed a subjective evaluation of our method by designing a perceptual user-study, demonstrating that editing has an impact on the perceived quality of the observed video stimulus; that each of the three terms in our cost function has a positive impact on perceived quality; and that the perceived quality of our version was not significantly lower than the version done by an expert film editor.

Our model is currently limited to the case of linear editing, where the chronology of events is maintained. In future work, we would like to allow temporal ellipses and re-ordering of events, and we are investigating higher-order Markov models and context-free grammars to overcome this limitation.

PART 3 SCIENTIFIC RESULTS OF THE TEAMS

Diffraction effects in material reflectance models ⁷Team MAVERICK

Photorealism is a long-term goal in image synthesis. We aim at creating pictures of a virtual world that looks, as much as possible, like a photograph. It is especially useful in special effects for motion pictures, where the transition from real pictures to computer-generated imagery must be as seamless as possible.

In recent years, research on photorealism focuses on material models, how an object reflects illumination. The micro-facet model is highly popular in both research and industry. In this model, the visual aspect of a material is determined by the surface roughness, through its micro-geometry.



In this model, the surface micro-geometry is made of micro-facets, and that we have a probability distribution function describing the orientation of their normals. We can then express the overall material reflectance as an integral of the micro-facet reflectance multiplied this probability distribution.

If we assume the micro-facets are specular, their reflectance is a Dirac and the integral collapses into a simple expression. The micro-facet model gives a connection between material aspect and surface roughness. It is relatively close to the measured reflectance.

But there are still differences between measured reflectance and what this model predicts: we observe that the reflectance dependence on wavelength is more complex than expected; also, on some materials, we observe a slope rupture, as if there were two different phenomena.

To go further, we need to question the assumptions of the micro-facet model. The main assumption is that we can use the rules of geometrical optics, because micro-facet geometry is larger than light wavelength. In the model, light moves in a straight line, independently of its color.

Our key idea is that this assumption is unlikely to hold: first, the wavelength of visible light (= 0,1 μ m) is large enough that some surface details will have similar dimensions. Second, there is no reason for surface details to stop at a certain threshold. If there are surface details whose dimension is close to the visible light wavelength, the incoming light will also be diffracted as it bounces on the surface. The equation connecting material reflectance and microgeometry becomes more complex.



To make it simpler, we introduced a two-scale model, where the geometry that diffracts (whose size is comparable to the wavelength) is laid on top of a larger-scale geometry. We end up with a usable equation, with two different behaviors that add up: the reflectance predicted by the micro-facet model and a second lobe, corresponding to the diffraction effects, which we express using a convolution.

All the odd behaviors in the micro-facet model disappear when we introduced diffraction effects. The new model is surprisingly good at predicting material behavior, with almost no differences between model and measures. Diffraction effects are relatively subtle, but important for the visual aspect of the material.

SAMSON - ERC Proof of Concept

NANO-D receives an ERC Proof of Concept to test the commercial potential of SAMSON

SAMSON, the software platform for computational nanoscience developed by the NANO-D group, has now more than IOOO registered users worldwide. Materials science, physics, electronics, bioinformatics, nanotechnology and chemistry study matter at the atomic scale. The SAMSON software platform supports this research by facilitating the visualization and virtual prototyping of atomic structures (proteins, nanotubes, molecular machines, etc.).

SAMSON has a generic, modular architecture, and users can customize it by adding SAMSON Elements (modules) from SAMSON. SAMSON Elements may contain apps, editors, force fields, numerical methods, visualization methods, property calculators, etc.

Developers can use the SAMSON Software Development Kit to create new SAMSON Elements and share them on SAMSON Connect. NANO-D integrates the algorithms developed in the group into SAMSON Elements (e.g. [I-3]), and other groups are using SAMSON as a platform for their research (e.g. [5-6]). SAMSON was developed in part thanks to grants from ANR (COSINUS SAMSON) and ERC (Starting Grant ADAPT). In 2016, NANO-D received an ERC Proof of Concept to test the commercial potential of SAMSON.

Would you board a plane that has never been tested? Nowadays, no prototype would take off before careful numerical modeling, testing, optimization using computer simulation. At Anatoscope, a young spin-off company from France's CNRS and INRIA research institutes, we believe that this digital pipeline will become a must in medicine, especially in orthopedics. Biomechanical simulation is mature enough to numerically optimize each personalized treatment before its application to the real person. What was still missing is the patient's personalized model. Anatoscope lifts the last obstacle on the way to personalized orthopedics, by automatically computing every patient's digital twin based on imaging.

A digital twin is to patient imaging what an architectural design is to pictures of a building: simplified but editable shapes, with additional information on materials and connections between the parts. Turned in digital twins, static imaging becomes virtual anatomy that can be processed to simulate motion and deformations in reaction to treatments. Until now, creating personalized digital twins based on imaging took weeks of highly skilled work, making time and delays incompatible with standard healthcare pipelines, and CAD advantages unsuitable to patients. Now, thanks to the Anatomy Transfer technology developed by Anatoscope based on LJK-INRIA technology, the digital twins are generated automatically by numerically warping a generic 3D avatar to patient imaging. Simulation can then be performed using a variety of standard or specialized softwares. This framework is adapted to each application by Anatoscope thus bridges the gap between imaging and biomechanical simulation, opening a new era in medicine!

Anatoscope has already attracted major partners in radiology including EOS Imaging, to complement their reconstruction with full anatomy for applications ranging from diagnostic to device design. Anatoscope also offers fast segmentation tools and prepares applications on per-operative tumor tracking using Augmented Reality. Finally, Anatoscope offers a fully digital production pipeline for personalized healthcare devices, from imaging to 3D printing. This no-plaster framework has been adopted by various businesses such as Thuasne for the production of knee braces, or Biotech Dental for dental prosthetics.

FUI project Vi4.2 : Industry 4.0, AI and the PCB industry

Vision 4.0 (in short Vi4.2) is one of the 8 projects labeled by Minalogic, the digital technology competitiveness cluster in Auvergne-Rhône-Alpes, that has been selected for the Industry 4.0 topic in 2016, as part of the 22nd call for projects of the FUI-Régions. This 3 year project involves 2 companies Vi-Technology (coordinator), ACTIA, and two laboratories, G-SCOP and Inria (Team Mistis from LJK), for a total budget of 3.4 MD.

Today, in the printed circuits boards (PCB) assembly industry, the assembly of electronic cards is a succession of ultra automated steps. Manufacturers, in constant quest for productivity, face sensitive and complex adjustments to reach ever higher levels of quality. Project VI4.2 proposes to build an innovative software solution to facilitate these adjustments, from images and measures obtained in automatic optical inspection (AOI). The idea is - from a centralized station for all the assembly line devices - to analyze and model the defects finely, to adjust each automatic machine, and to configure the interconnection logic between them to improve the quality.

Transmitted information is essentially of statistical nature and the role of the Mistis team is to identify which statistical methods might be useful to exploit at best the large amount of data registered by AOI machines. Preliminary experiments and results on the Solder Paste Inspection (SPI) step, at the beginning of the assembly line, helped determining candidate variables and measurements to identify future defects and to discriminate between them. More generally, the idea is to analyze two databases at both ends (SPI and Component Inspection) of the assembly process so as to improve our understanding of interactions in the assembly process, find out correlations between defects and physical measures and generate accordingly proactive alarms so as to detect as early as possible departures from normality.

Statistical tests for Genomics [,] Team SVH

A major issue in present medical research is to reliably associate pathologies to gene expressions in patient's tissues. Genomic data are made available on the internet almost on a daily basis, thus producing an impressive mass of information that must be statistically treated. This information may consist in lists of genes known to be associated to cellular functions, pathologies, tissues, etc. It may also consist in expression data, i.e. vectors of numeric values for the whole of the 20,000 genes in the human genome. The question of integrating data from several experiments in a single statistical analysis remains largely open. The drawback of existing statistical techniques is that they do not take into account some particular phenomena, although they can be observed in all known databases. One of them is the huge variability between a small number of genes highly and often overexpressed, and the vast majority of genes, which have low expressions in general. Another phenomenon is the high correlation between expressions from two different genes, whether they are biologically related or not. Both induce a lot of spurious artefacts, which are difficult to distinguish from true biological information.

The LJK team SVH (statistics for life sciences) has been developing a collaboration with researchers in biology and medicine since 2014, particularly with the Canceropole in Toulouse through the Labex TOUCAN (Toulouse Cancer, Jean-Jacques Fournié), and with the Institut Albert Bonniot in Grenoble (Sophie Rousseaux). Foreign collaborations include the Los Alamos National Laboratory and Georgia Institute of Technology (Philip Gerrish). Several new statistical techniques have been developed and tested on real data through these collaborations. They have been included in a new R package, STODA (Statistical Techniques for Omics Data Analysis). This package is currently under testing in Sophie Rousseaux' team. Once tested and validated, it will be transformed into a web application automatizing the statistical treatment of large omics datasets.
